GVL shall be entitled to authorise the rights administration society in the United Kingdom (VPL - Video Performance Ltd.) with the rights administration vis-à-vis the broadcaster.

- The right to broadcast
- The right to dissemination by means of simulcasting (simultaneous, uncut and unaltered dissemination of TV programmes via publicly accessible pages on the internet via streaming)

The administration of these rights shall be restricted to all channels/programmes of MTV Networks Europe which are broadcasted from the countries listed in Annex 1 as "Territory" and which can be received in the countries listed in the same annex as "Footprint Territory", with the exception of those channels/programmes for which the respective rights are either not exploited or – based on existing contracts – are already administered by other rights administration societies (the list of such channels/programmes is attached as Annex 2 – for GVL's scope these are the programmes VIVA and Comedy Central).

These rights shall be assigned with effect from the date of signature and shall be in force until they are revoked. Such a revocation shall be in writing and subject to a deadline of one year.
